Pursuant to O.R.C. 3327.08 and O.R.C. 3313.46

Sealed bids will be received by the Board of Education of the Avon Lake City School District for one (1) school transportation van. The bids will be received at the Treasurer's Office, 175 Avon Belden Road until **12:00 p.m., Noon, local time on Monday, January 30th, 2023**, and will be read publicly and recorded immediately thereafter. Late bids will not be accepted and will be returned unopened. Faxed and/or emailed bids are not permitted.

Bids shall be addressed to the Treasurer of the Avon Lake City School District in a sealed, opaque envelope and be clearly marked on the envelope as a bid for the applicable school transportation van for which the bidder is submitting its bid along with the bidder's name.

The bidding documents, including copies of the van specifications, bid form, forms of contract and bond, and addenda are on file and may be obtained on the Board of Education's website at www.avonlakecityschools.org/district/operations/RFP. Bidding documents are also on file and may be reviewed at the Board of Education Office, 175 Avon Belden Road, Avon Lake, Ohio 44012, from 9:00 a.m. to 3:00 p.m., Monday through Friday, except for legal holidays of the School District.
